*Just in case you forgot, here's the complete record of our dialog regarding the images. You will note that at no point did I give you my images, nor did I make them available by any means other than to provide you with instructions on how to embed **my** gallery into your website for promotional purposes as an example of the services I provide to my clients. The rates that I quoted were discounted because Slava & Herman told me to give you the best rate I could which is well below my standard rate of \$100/Hr. I had hoped to develop an ongoing relationship where I could provide you with even better pricing based on the volume of work.*

Perhaps now, with this written reminder, you will understand why I'm steadfast in my position which is:

Regardless of what you have said on the phone, the actions involved in:

- A) **Bypassing my security to get copies of my images, and;***
 - B) **Removing my embedded digital copyright and overwriting my copyright watermark;***
- clearly prove beyond any reasonable doubt the intent to steal my copyrighted work.*

I'm sure you will now also understand why the 'promise' of future paid work in no manner compensates me for the damages already done to my business, my art, and my reputation through your felonious actions.

Clearly there was no need to steal my images. Just because my family emigrated in the mid 1800's doesn't change the fact that we share a common heritage. I really did not expect to be screwed like this by one of my own when in fact I was looking forward to learning more about that heritage from you and others in the Philadelphia area Russian community.

Some of the images have undergone full retouching while others have only undergone basic retouching, I'm sure you'll be able to see the difference. Feel free to give me a ring anytime to discuss future events, as I had indicated my rates are very reasonable for what I produce at \$200 for up to 4 hours and \$400 for up to 8 hours. I can also produce a stand-alone flash gallery that can be embedded into MySpace or any other public site and deliver that on CD or via Download.
